

1. The evaluation of the Project work of 20 marks of Economics for the ensuing HS Final Exam, 2022 will be as follows:
  - a) 12 marks will be evaluated internally by the concerned department.
  - b) 8 marks will be evaluated by an External Examiner along with an Internal Examiner of the concerned dept.; based on the viva considering the following:
    - i) Clarity on the topic, knowledge & understanding (5 marks)
    - ii) Project Presentation & communication skill (3 marks)
  - c) The Head of the Dept./concerned subject teacher will make the necessary arrangement for availability of the project report duly certified by the guide to the concerned External Examiner on the day of the viva.
2. The pass mark in the project work is 06 out of 20 and pass mark for the theory is 24 out of 80.
3. Each student will have to pass individually in both theory & project work.
4. The Head of the concerned institution needs to appoint an External Examiner in consultation with the head of the department of the concerned subject / department.
5. The External Examiner should be senior faculty of Govt/Provincialised Higher Secondary Schools/Colleges/Universities.
6. The Internal Examiner will be appointed by the head of the department.
7. This particular structure of the project evaluation will be valid only for the HS 2<sup>nd</sup> year Final Examination, 2022.
